- Ensure gender parity in ICMCI's structure like committees and board

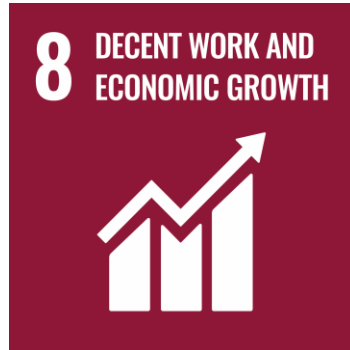


# ICMCI contributes to the following 10 SDG's
