

## REPORT OF THE MEMBERSHIP COMMITTEE ASTANA 2017

#### **RECOMMENDATIONS TO THE BOARD**

September 4, 2017

#### **EXECUTIVE SUMMARY**

As outlined in the Member in Good Standing Policy, which was approved by Trustee vote after the 2014 Seoul Congress, the Membership Committee has undertaken the annual review of the ICMCI membership.

This report presents our recommendations to the Board. It is the product of our review of each member's:

- 1. QAC assessment status,
- 2. Account status, and
- 3. Member communication and engagement.

Where we identified issues and concerns, we have communicated this to the Executive Director, the QAC Committee, and/or the Treasurer, as appropriate.

We have **49 provisional and full members**. We are pleased to **recommend the confirmation of 47 members as being in Good Standing**, as at August 1, 2017, detailed as follows:

Full members Provisional	43 <u>6</u>
TOTAL FULL & PROVISIONAL MEMBERS	49
<b>Less:</b> Members recommended for immediate action to rectify	<u>-2</u>
TOTAL MEMBERS IN GOOD STANDING	47

There are an additional 4 members who have submitted their applications for provisional membership and are awaiting assessment by the QAC. In addition, there is 1 application for provisional membership in progress. This activity totals 54 members, at various stages of membership.

We are recommending that 2 members be officially informed of the need for immediate action to rectify due to a number of factors, but the key determinant has been non-responsiveness to communication.



We note that of the 47 members in good standing, we have 11 who have issues with their membership in good standing, and these members are slated to be reviewed in Q4/2017 to see if their issues have been resolved.

Therefore, there are 36 members who are identified as completely in good standing.

Since our last report, we are disappointed with the trend to have so many members who have issues with their MGS status. Many of these issues have been outstanding previously, but these have not been rectified with the passage of time.


We trust the attached set of recommendations meet with the Board's approval, and as a committee, we stand ready to address any questions or concerns that the Board may have.

#### **DETAILLED REPORT ON MEMBERSHIP STATUS**

#### **Membership Status:**

Please note that we have included many comments so the Board understands the issues at hand. Comments in ALL CAPS represent the recommendation from the Membership Committee.

These recommendations follow the assessment of each member IMC against the three key criteria set out by the Membership Committee:

- 1. QAC assessment status,
- 2. Account status, and
- 3. Member communication and engagement.

A number of IMCs have some issues with their membership that must be clarified. The decision to recommend "immediate action to rectify" was not taken lightly. That is why we have recommended on 11 members, that they be given until Q4/2017 to rectify the outstanding issues. For these members, we have recommended a short Member in Good Standing renewal.

For the 2 members where we have recommended "Immediate action to rectify", there were a number of issues, but the decision ultimately came as a result of non-communication.

We appreciate that the Board may decide to accept or not accept the suggested recommendation for each specific member IMC, due to extenuating circumstances.
