RECOMMENDATIONS TO THE BOARD

August 30, 2018 MEMBER IN GOOD STANDING REPORT

As outlined in the Member in Good Standing Policy, the Membership Committee has undertaken the annual review of the ICMCI membership.

This report presents our recommendations to the Board. It is the product of our review of each member's:

- 1. QAC assessment status,
- 2. Account status, and
- 3. Member communication and engagement.

Where we identified issues and concerns, we have communicated this to the Executive Director, the QAC Committee, and/or the Treasurer, as appropriate.

At the end of August, we are pleased to report we have **50 provisional and full members and 1 applicant**. We are pleased to **recommend the confirmation of 48 members as being in Good Standing**, as at August 28, 2018, detailed as follows:

As noted above, there is 1 member who have submitted their application for provisional membership and are awaiting assessment by the QAC. 2 countries who had submitted their application for provisional membership stopped their application when they found out more about the requirements.

During the course of the year, we are sad to report that 2 members whose membership has been officially terminated. Both the Board and Executive Director exercised extreme care, prior to reaching this conclusion. These countries are not included in our counts in the table above.

We note that of the 50 members, we have 2 who have issues with their membership in good standing. One member's lack of adherence to our standards is clear, and we have recommended them for suspension. One member has issues with their communication so we have recommended a warning, with a review in Q4/2018 to see if their issue has been resolved.

We are pleased that, year over year, we have 2 additional members in good standing, compared to last year. We thank the Board for taking action with our report from last year and believe that has been a key factor in our review this year.

In our report last year, we reported 11 IMCs who had some issues with their membership that had to be rectified. We are pleased to report that most IMCs rectified the outstanding situation. This year's review of members was much easier to conduct and the situation improved significantly. We appreciate the support of the Board and the Executive Director.

This year, only 1 IMC has an issue that needs to be rectified. We suggest they be warned and allowed until Q4/2018 to rectify the outstanding issue.

Unfortunately, we have 1 member where we have recommended "suspension". There has been a number of issues, but the decision to suspend ultimately came as a result of non-communication and non-payment.

Finally, during the year, we recommended 2 members to be terminated. The Board and Executive Director made extraordinary efforts and exercised extreme care before we came to this conclusion, which was approved by the Board. We have left these IMCs on our list, so the past memory is not lost.

We trust the attached set of recommendations meet with the Board's approval, and as a committee, we stand ready to address any questions or concerns that the Board may have.
