RECOMMENDATIONS TO THE BOARD

*MEMBER IN GOOD STANDING REPORT*

As outlined in the Member in Good Standing Policy, the Membership Committee has undertaken the annual review of the ICMCI membership.

This report presents our recommendations to the Board. It is the product of our review of each member's:

1. QAC assessment status,
2. Account status, and
3. Member communication and engagement.

Where we identified issues and concerns, we have communicated this to the Executive Director, the QAC Committee, and/or the Treasurer, as appropriate.

In our draft report of August 1, 2020, we reported that we had concerns over the status of 12 IMCs. The Executive Director contacted the IMCs where we had identified issues. 9 IMCs took positive action that corrected their status. 1 IMC requested they be suspended due to ongoing operational issues. This leaves 2 full members who, we recommend, will have 3 months (until Dec 31, 2020) to rectify their issues, before we consider suspension.

With this updated version of our report, we are pleased to report we have 48 provisional and full members. We are pleased to recommend the confirmation of 41 full and 4 provisional members as being in Good Standing, as at September 21, 2020 detailed as follows:
