ADDENDUM TO THE MEMBER IN GOOD STANDING REPORT

Submitted October 9, 2019 (must be read in conjunction with the report submitted August 15, 2019)

In our original report submitted on August 15, 2019, we reported to the Board that we had concerns over 7 IMCs. The Executive Director contacted the IMCs who had issues outstanding.

Thanks to the actions of the Executive Director and the IMCs, we are pleased to report that of the **51 provisional and full members**, we now have **49 members as being in Good Standing**, as at October 9, 2019 detailed as follows:

We have attached an updated spreadsheet showing the Members in Good Standing.

Of the 7 IMCs where we had concerns, 5 of them responded to our Executive Director's warning and either rectified the issue or made acceptable arrangements.

Of concern, **we have 1 who did not respond to the warning, plus 1 that we recommended for suspension, and they did not respond. Both IMCs have issues with their membership in good standing, and we recommend action must be taken to suspend.**

LAST MINUTE UPDATE: Just as this report went to press, we were sad to receive notice from Denmark that they have decided they have shrunk to a point below critical mass and they are terminating the IMC. They will recommend the remaining members join CMC-GI. As this news was just received, this change is not reflected in the MGS report numbers.
